Opening Date	The opening date for entries is 08 June 2026.
Closing Date	The closing date of the prize draw is 5PM on 15 June 2026.
How to enter	<p>To enter the prize draw you need to:</p> <ul style="list-style-type: none"> • follow the Promoter on Instagram or Facebook, • comment on the prize draw announcement post following the question prompt; "Tell us your most memorable Leeds Rhinos game?"; • only responses which provide a reply as a comment will be counted. This will be determined by the Promoter. <p>All entries must be submitted via Facebook or Instagram.</p> <p>You will need to provide your name and email address. If the prize is to be delivered then the address of the winner will also need to be provided.</p> <p>One entry per channel only, meaning you can enter once on Instagram and once on Facebook.</p>
Cost	The prize draw is free to enter and no purchase is necessary.

Who can enter	<p>Individual, UK residents, who are aged 18 or over.</p> <p>Employees (including contractors and temporary employees) of the Promoter, their families, agents or any third party directly associated with administration of the prize draw cannot enter.</p> <p>Employees (including contractors and temporary employees) of Leeds Rhinos, their families, agents or any third party directly associated with administration of the prize draw cannot enter.</p>
Winning entry	<p>The winner(s) will be selected by a random draw from all eligible entries in the week commencing 15 June 2026.</p>
What happens if you win	<p>The winner(s) will be notified of the result by direct message on Facebook or Instagram by 22 June 2026.</p> <p>If the winner(s) cannot be contacted within fourteen days then the prize will be forfeited and the Promoter will be entitled to select another winner in accordance with the process described above.</p> <p>Once notified, winners will have seven days to confirm to the Promoter that they meet the eligibility criteria and wish to accept the prize.</p> <p>The winner will be asked to provide their full name, address. The Promoter will post a shirt to the winner within 30 days of confirmation that they wish to accept the prize. UK addresses only.</p>
